A. Executive Director Report (Farid)

Farid Senna went over the ED report.

- Discussing interactions between Board members and parents, Farid suggests that parent board members watch the nature and details of interactions with staff related to operations or the school since their opinion can be interpreted as the Board's or the school's opinion.

There were questions about status update on equity initiatives, staff professional development, staff evaluations, teacher recruitment for next year. There is no update on equity at this time. The PD plan is proceeding as outlined at a previous Board meeting. 80% of teachers have been evaluated. Re-hires of teachers should be finalized by February. Teacher recruitment is slowed down by paperwork being done with the French Consulate to allow "détachement" for French teachers, thanks to the French Label. A third French teacher is mandatory on our staff next year, because of the Label.
