- A. FY2019 Financials Review (Peter & Mark) 15 min
 - a. uncategorized revenue and expenses
 - i. Down to \$7800 this month.
 - ii. Mark to own the process of reducing the amount of uncategorized revenues and expenses
- B. September YTD budget vs actual financials review (Peter) 15 min
 - a. Mark's staff to get from Edtec the form to fill out to receive ADA reimbursement for school closures caused by PG&E blackouts
 - b. A Special Aid teacher is still needed for compliance reasons. The school will need about about 25K for the remainder of the school year
 - c. BASC:
- i. \$18K over budget
- ii. Madhu to send to Mark current expenses and revenues expectations
- iii. 2 new resources on payroll, for the after school programs. Mark to review the needs and make decision moving forward
- iv. Mark to clarify revenues and expenses for BASC and when revenues can be recognized
- d. ED may need Board approval to be able to borrow money to make payroll due cash crunch. The Finance committee recommended unanimously that the Board of Directors gives the Executive Director the authority to secure a loan to use for the upcoming cash flow crunch.

 - a. Clarify amount or projected school reserves (Peter)
 - b. Define process for creating a revised budget
 - c. Set viable goals to bridge current budget shortfall
 - d. Review Fundraising Goals
