  - a. Forecast to end the year with 301K deficit
  - b. Need to figure a way to collect payment checks during the stay in shelter
  - c. Impact of closure: (ED)
    - i. No legal duty to provide SPED, so potential savings. More details next meeting
    - ii. Savings from janitorial. We will cancel or reduce janitorial services.
    - iii. Potential substitutes budget
    - We are paying all employees, even the hourly employees.
      Recommendation from ED is to continue paying employees during the shutdown.
    - v. Can we explore unemployment options where we reduce employees hours and have them file unemployment?
    - vi. Recommend letting the BASC staff go on to unemployment since the funding from the activities come from parents' payment. Mark to get a second opinion from the Board at the next meeting.
- B. Fundraising (Mark Kushner/Frédéric Boulay/Sabine Anderson)
  - a. Annual Gala
  - b. Gala is cancelled because the venue is not able to host the gala.
  - c. The Gala Committee is considering moving it to fall, online auction or an emergency fund raising
  - d. The Gala committee is considering an online auction, but there are concerns over the timing and whether it will raise enough money.

- e. Implications of not having the Gala:
  - i. Will need to do more receivables for cash flow. Need to make sure we can sell receivables. We need to understand the risk.

  - b. Motion to give the ED the authorization to give teachers and staff new contracts for the new school year.
